- District Development Committee Update (Jessica Bohon & Circe Sher):
 - The Committee will meet again to discuss a standard operating procedure for the Legacy Grants as well as prep for the next round of grants. The group will also discuss whether we should move towards a once-a-year grant format.
 - The City of Healdsburg requested an early grant for the Merry
 Healdsburg celebration because the tree needs to be purchased in July.
 With the decreased T.O.T. this year, they are requesting information on
 the grant amount for the next round.

 - Current Projects Updates:
 - Summer Photo Shoots J/PR will be conducting their content mission for social media assets the second week of July. We will

then work with Kim Carroll in September for another photoshoot to focus on summer shots and images for the website and advertisements.

- Madden Media Transition Madden Media is ready to begin and has been meeting with Jessica to give current audits on SEO, website, email marketing, and ad buys.
- Season to Sparkle Pitch Jessica is finishing up the long-lead pitch to go out to the journalists through J/PR and with media mailers. The next step will be to work with Daniella to get the word out to all of the Chamber members and to start a timeline with the downtown retail group for the window decorating contest.
- HTID Finance Committee Update:
 - Consistent with last month, there was \$1.26 million in the bank.
 Operating checking funds are \$761,068 (Total 1000 Bank accounts \$1,263,083 less Total 1040 Available Funds by Class \$324,612).
 - Overall, the January to May net deficit of \$231,575 was 213.9% higher than budget and \$245,809 larger than January to May 2023. Most of this was a timing difference (District Development grants \$119,500). Year over year changes are largely attributed to sales, marketing, and agency fees.
